Stimulus Funds and the Ohio Ethics Law

On March 11, 2021, the American Rescue Plan Act of 2021 was signed into law and is intended to combat the COVID-19 pandemic, including public health and economic impacts. Subsequently, at its June meeting, the Ohio Ethics Commission reminded public officials of the Ohio's Ethics Law governance over such federal stimulus funds.

In fact, the Commission encouraged public employees and officials in Ohio to review the previously issued <u>Advisory Opinion 2009-06</u>. The opinion concluded that stimulus expenditures constitute public contracts and are therefore governed by the Ethics Law which assures Ohioans that government decisions and public expenditures, whether at the state or local level, are objective and serve the public's interest. As result, the opinion continues to serve as clear guidance that public officials remain subject to the Ethics Law when making any determinations regarding federal stimulus funds.

Advisory Opinion 2009-06 reminds public officials that they cannot profit from federally funded contracts or participate when family members or business associates might benefit from them. It outlines prohibitions against public officials misusing their public positions to secure stimulus funds or participating in any actions involving the funds, where family members or business associates of the public official may otherwise lawfully have some direct benefit from the contract.

Ethics Commission staff members are pleased to work with the public in understanding and complying with the Ohio Ethics Law. We provide advice, information, education, and training tools regarding conflicts of interest in public service, gift prohibitions, public contract restrictions, nepotism, and much more. The Commission also conducts investigations regarding alleged violations of the Ethics Law and related statutes.

This work in upholding the law promotes honesty in government and supports the public confidence in public service. As a result, the Commissions welcomes questions regarding the Ethics Law; in fact, you can contact our office directly or review our website for information regarding the law and the work of the Ethics Commission.

However, we also receive numerous questions throughout the year regarding issues outside the Ethics Commission's jurisdiction. Because we want to be helpful to all our callers, we compiled a fact sheet available on our website entitled "The Authority of the Ohio Ethics Commission."

In this document, we outline the areas of the law over which the Ethics Commission has jurisdiction and can offer information and assistance. You will also find a list of common issues outside our jurisdiction and the appropriate authority to instead contact. Examples of the issues outside the Ethics Commission's authority include:

- Sunshine Law (Open Meetings/Public Records)
- Lobbying or General Assembly Regulations
- Campaign Finance or Elections
- Codes of Professional Conduct

- Sexual harassment or Discrimination
- Substandard Government Customer Service
- Theft in Office or Bribery

Are you a Public Practice Attorney? Need CLE? Look No Further!

Each year, the Ohio Ethics Commission and the Ohio Board of Professional Conduct provide free Continuing Legal Education (CLE) courses each year for public practice attorneys. These free classes are approved by the Supreme Court of Ohio Commission on Continuing Legal Education for 2.50 total CLE hours of attorney professional conduct instruction.

Our first class took place in May and was a live webinar and was well received by nearly 500 public practice attorneys from throughout Ohio. We are offering two additional opportunities this year, one online and one in-person:




Ethics Education - Regional Sessions
