### CALL TO ORDER

The meeting of the Ohio Ethics Commission was called to order at 12:06 p.m. in Room G on Level 3 of the William Green Building, at 30 West Spring Street, in Columbus, Ohio.

## **ROLL CALL**

The following Commission Members were present: Mr. Brachman, Mr. Bailey, Ms. Kelley, Ms. Ross-Dolen, Ms. Tracy, and Mr. Vander Laan. Staff present: Executive Director Paul M. ### PREVIOUS MEETING MINUTES

The Commission reviewed the draft minutes from the September 29, 2023, Commission meeting.

MOTION Ms. Tracy, seconded Ms. Kelley, that the Commission approve the minutes of the September 29, 2023, Commission meeting. The motion passed unanimously.

### ADVISORY OPINIONS AND STATISTICS

Mr. Nick presented the advisory statistics and activity report, noting the new manner that staff is using to present comparative opinion statistics by using relative percentages rather than raw numbers. Mr. Woeste noted the Advisory Committee will be addressing the City of Columbus's opinion request during its meeting later this afternoon. Mr. Brachman asked a question about an opinion to which Ms. Saks answered. Mr. Woeste also provided historical context for an advisory opinion subject noted in the activity report.

### EXECUTIVE DIRECTOR'S REPORT

Mr. Nick updated the Commission on a proposed administrative rule amendment and Department of Administrative Services vehicle policy updates that require all state fleet vehicles to install telematics equipment to monitor vehicle location and performance data.

## **LEGISLATION UPDATE**

Mr. Hood reviewed the information shown in the packet. Mr. Hood mentioned HB 257 and a hearing held on October 3, 2023. Mr. Hood stated this bill would give agencies the ability to meet virtually and, if passed, it appears that it would apply to Ethics Commission meetings and Committee meetings. Mr. Bailey requested a copy of the summary of that bill. Mr. Brachman asked for more information about SB 133 related to vendor debarment and if any action had been taken yet.

#### PUBLIC EDUCATION AND INFORMATION

In Ms. Willeke's absence, Mr. Nick reviewed the information in the packet. Mr. Nick mentioned the Commission will be issuing a fourth quarter newsletter at the end of the year and noted that the 50<sup>th</sup> anniversary of the Ethics Commission will be in 2024.

# FINANCIAL DISCLOSURE STATISTICS REPORT/COMPLAINT REPORT

Mr. Ring reviewed the report as shown in packet. Mr. Ring noted that the number of filers who filed their 2022 financial disclosure statements late was currently only at 3.6% but that he expects the number to increase to around 4.5%, as the remaining non-compliant filers file their statements.
